

**RE: Cancellation of your Reloadable Prepaid Walmart MoneyCard®**  
**Effective Date: August 1, 2018**

Dear Cardholder:

According to our records, you have registered the Reloadable Prepaid Walmart MoneyCard® identified above (**Card**). In accordance with your Cardholder Agreement, Money Network is notifying you that effective **August 1, 2018**: (1) the Reloadable Prepaid Walmart MoneyCard® program will be discontinued, and (2) your Card will be cancelled and your Cardholder Agreement will be terminated. **As of August 1, 2018, you will no longer be able to use your Card or Money Network Checks to complete transactions.**

**Please read the following, which contains important information you will want to remember.**

- You can continue to load your Card on or before June 15, 2018. After June 15, 2018, you will no longer be able to load funds to your Card - including with cash, direct deposit, money transfers or other load methods. **We strongly suggest that you take the steps necessary to change any automatic direct deposits to your Card that you may have set up as soon as possible and ideally no later than June 1, 2018. Automatic direct deposits will not be processed after June 15, 2018.** (Your payor's processes for making changes to automatic direct deposits may impose additional time restrictions.)
- You can continue to use your Card on or before July 31, 2018. As of August 1, 2018, you will no longer be able to use your Card or Money Network Checks to access the funds on your Card - including through purchases, ATM withdrawals, automatic payments, or other transactions. **We strongly suggest that you take the steps necessary to change any automatic payments that you may have set up with your Card as soon as possible and ideally no later than July 15, 2018.** (Your vendor's processes for making changes to automatic payments may impose additional time restrictions.)
- Any funds in excess of \$1.00 remaining on your Card (net of any applicable fees) after discontinuation of the program and final settlement of your Card transactions will be sent by check to the above address associated with your Card on or before September 15, 2018. If your remaining Card balance is \$1.00 or less and you would like a balance refund check mailed to you, please call the Customer Service number on the back of your Card. (You will not be charged the Balance Refund Check fee for checks sent after discontinuation of the program.)
- If the above address associated with your Card is not your most current address, please promptly call Money Network Customer Service at 1-800-532-0938 and provide your current address to a customer service representative. **It is vital that your mailing address on file with Money Network is current because we will mail a check to you at this address via U.S. Postal Service between August 20 and September 15, 2018 for your remaining Card balance (subject to the terms of this letter).**
- Please see your Cardholder Agreement for any additional applicable restrictions or terms.
